## BIOGRAPHY

Bob Kustra, the 42nd Lieutenant-Governor of Illinois, has compiled an impressive record as legislator, educator and public servant and was re-elected in 1994 to serve a second term. His extensive experience, high degree of competence and forthright attitude in relation to public matters led to a dramatic expansion of the role of the Lieutenant Governor.

He oversees the direction of the Department of Commerce and Community Affairs and is the chairman of the Economic Development Council that guides efforts to coordinate economic development programs.

Lieutenant Governor Kustra serves as the Governor's point person on education, monitoring Chicago school reform and is the chairman of the Task Force on School-to-Work Transition. He has also spearheaded efforts to apply the latest technology to classroom learning and job training.

Bob Kustra holds a doctorate degree in political science from the University of Illinois and a master degree in public administration from Southern Illinois University. He teaches part-time at Northwestern University.

Bob is married to Kathy and is the father of two, Jennifer and Steve, and the stepfather of one, Matthew. The Kustras reside in Park Ridge.

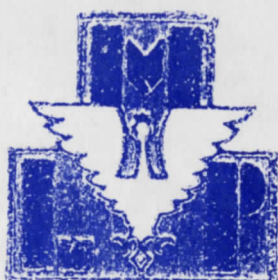
